SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Product is non-flammable, low risk of fire by the inflammability characteristics of the product in normal conditions of storage, manipulation and use. 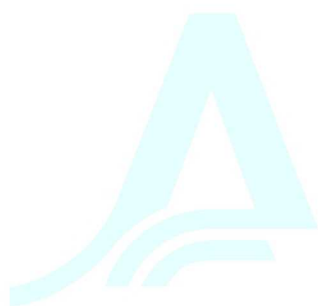
